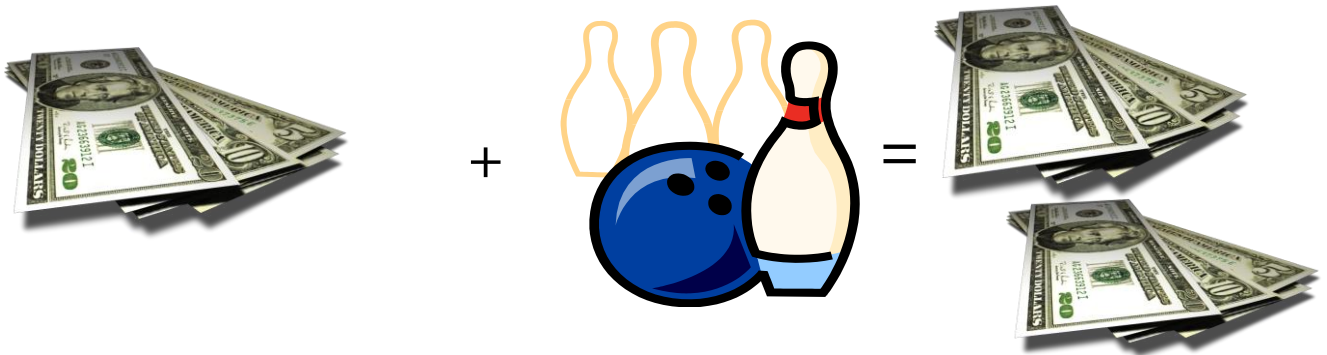

RULES AND REGULATIONS

1. This tournament shall be sanctioned USBC and operate under USBC rules not specified here. Non-USBC bowlers may participate in the tournament by purchasing an unattached membership card at the site for \$25.00. USBC cards are required at check in. Any bowler that is found ineligible to hold a USBC sanction cards shall forfeit any claims to the refund and/or prize money and all scores associated with this bowler shall be disqualified.
2. This Tournament shall commence on May 15, 2010 and end on May 16, 2010. Squads will begin @ 12:00 noon on **Saturday** with last squad @ 6:00pm and **Sunday** squads will begin 12:30pm with last squad @ 4:30pm. Minimum of two (2) Teams will constitute a squad. ALL ENTRIES WILL CLOSE (15) MINS. BEFORE ALL SQUADS. (Tournament will end last squad MAY 16th, 2010).
3. All entrants must submit their highest USBC BA/WBA 2008-2009 season book average. If no book average, bowler must use their current highest USBC BA/WBA 2009-2010 sanction average based on a minimum of 45 games in order to participate in this tournament. **Bowlers MUST provide a current league standing sheet as verification of their current average.** If no previous or current season average THE ENTRANT WILL BOWL 210 SCRATCH. **The 10 pin rule DOES NOT APPLY. A minimum entering average for male/female will be 145.**
4. PBA and PWBA members are NOT eligible to participate.
5. It shall be each bowler's responsibility to verify the ACCURACY OF HIS/HER AVERAGE, whether originally submitted by the bowler, his/her partner, or others. Failure to use the correct average shall disqualify score if submitted average is lower than correct average. Prize winnings will be based on the average submitted to the Tournament if it is higher than the correct average.
6. Re-entries are permitted. Bowl as often as you wish, but you may CASH ONLY ONCE WITH SAME PARTNER. Change partners and cash again. Multiple participation is permitted in **singles** event; A BOWLER MAY CASH ONLY ONCE IN THE PRIZES LIST FOR POSITION STANDINGS.
7. All teams will bowl three (3) games on the same pair of lanes with total pins plus handicap deciding the Tournament Winner.
8. HANDICAP IS 80% of 210 FOR MEN AND WOMEN Payouts - RATIO 1:10
9. Entrants must pay their entry fee (\$50.00 per team) with \$10.00 optional singles before beginning competition. **CASH ONLY!!**

Directions to First State Lanes

From Baltimore/Washington – Take I-95 North to Wilmington and get on I-495 North. Exit I-495 at Edgemoor Ave bearing right to light. At light, make left on Governor Printz Blvd to next light. Make hard right at light, First State Bowling Center is at top of hill to your left.

From New York/New Jersey (Turnpike) – After crossing Delaware Memorial Bridge, follow signs for I-495 North. Exit I-495 at Edgemoor Ave. bearing right to light. At light, make left on Governor Printz Blvd to next light. Make hard right at light, First State Bowling Center is at top of hill to your left.

From Philadelphia – Take I-95 South to I-495. Exit I-495 at Edgemoor exit. At light make a left. At second light make a hard right. At top of hill, First State Bowling Center is on your left.
